Hostel Rules

1. Students must be back in the hostel by 5:00 PM. Late comers will not be allowed to enter the hostel without permission from the Hostel Warden.
2. Silence hours will be observed from 9:00 PM to 6:00 AM. Students must maintain silence during this time.
3. Lights will be switched off at 10:00 PM. Students must be in their beds by this time.
4. Visitors are allowed only during designated visiting hours (Sundays, 10:00 AM – 2:00 PM).
5. Students must take permission from the Hostel Warden before leaving the hostel.

Discipline and Conduct

1. Students must show respect to the Hostel Warden, teachers, and other hostel staff.
2. Students must keep their rooms and common areas clean and tidy.
3. Bullying of any kind will not be tolerated.
4. Physical fights will result in immediate disciplinary action.
5. Students are not allowed to gather in groups in the hostel without permission.

Safety and Security

1. Students are not allowed to use electrical appliances (e.g., heaters, irons) in their rooms.
2. Students must provide an emergency contact number to the Hostel Warden.
3. Students must ensure that the hostel gates are closed and locked after entering or exiting the hostel.
4. The school cannot be held responsible for accidents, small or serious to the students during school hour, Under hostel or excursion.

Health and Hygiene

1. Students must maintain personal hygiene and cleanliness.
2. Students must report any illness or sickness to the Hostel Warden immediately.
3. Students must not self-medicate. All medicines must be approved by the Hostel Warden.
4. Students must follow proper food and water hygiene practices.

Property and Belongings

1. Students must label their personal belongings and keep them secure.
2. Students must respect and take care of hostel property (e.g., furniture, fixtures).
3. Students must report any lost or found items to the Hostel Warden.

Consequences of Misbehavior

1. First-time offenders will receive a warning.
2. Repeated offenders will face detention.
3. Serious offenders will face suspension from the hostel.
4. Extreme cases of misbehavior will result in expulsion from the hostel.

Consequences of Running Away

1. If a student is found to have run away from the hostel, the Hostel Warden will immediately notify the school administration and the student's parents/guardians.
2. The student will face disciplinary action, which may include:
 - Suspension from the hostel for a specified period
 - Detention
 - Loss of privileges
 - Expulsion from the hostel (in extreme cases)
3. The student will be required to undergo counselling to address any underlying issues that may have led to the student running away.
4. School will be not responsible if the student runaway from the hostel because of his/her personal reason.
